Overview

Contoso, Ltd. is a consulting company that has a main office in Montreal and two branch offices in Seattle and New York.

The Montreal office has 2,000 employees. The Seattle office has 1,000 employees. The New York office has 200 employees.

All the resources used by Contoso are hosted on-premises.

Contoso creates a new Azure subscription. The Azure Active Directory (Azure AD) tenant uses a domain named contoso.onmicrosoft.com. The tenant uses the P1 pricing tier.

Existing environment

The network contains an Active Directory forest named contoso.com. All domain controllers are configured as DNS servers and host the contoso.com DNS zone.

Contoso has finance, human resources, sales, research, and information technology departments. Each department has an organizational unit (OU) that contains all the accounts of that respective department. All the user accounts have the **department** attribute set to their respective department. New users are added frequently.

Contoso.com contains a user named User1.

All the offices connect by using private links.

Contoso has data centers in the Montreal and Seattle offices. Each data center has a firewall that can be configured as a VPN device.

All infrastructure servers are virtualized. The virtualization environment contains the servers in the following table.

Server2	Hyper-V host	VM2

Contoso uses two web applications named App1 and App2. Each instance on each web application requires 1 GB of memory.

The Azure subscription contains the resources in the following table.

The network security team implements several network security groups (NSGs).

Contoso plans to implement the following changes:

- Deploy Azure ExpressRoute to the Montreal office.
- Migrate the virtual machines hosted on Server1 and Server2 to Azure.
- Synchronize on-premises Active Directory to Azure Active Directory (Azure AD).
- Migrate App1 and App2 to two Azure web apps named WebApp1 and WebApp2.

Technical Requirements

Contoso must meet the following technical requirements:

- Ensure that WebApp1 can adjust the number of instances automatically based on the load and can scale up to five instances.
- Ensure that VM3 can establish outbound connections over TCP port 8080 to the applications servers in the Montreal office.
- Ensure that routing information is exchanged automatically between Azure and the routers in the Montreal office.
- Enable Azure Multi-Factor Authentication (MFA) for the users in the finance department only.
- Ensure that webapp2.azurewebsites.net can be accessed by using the name app2.contoso.com.
- Connect the New York office to VNet1 over the Internet by using an encrypted connection.
- Create a workflow to send an email message when the settings of VM4 are modified.
- Create a custom Azure role named Role1 that is based on the Reader role. ▪

Scenario: Ensure that VM3 can establish outbound connections over TCP port 8080 to the applications servers in the Montreal office.

IP flow verify checks if a packet is allowed or denied to or from a virtual machine. The information consists of direction, protocol, local IP, remote IP, local port, and remote port. If the packet is denied by a security group, the name of the rule that denied the packet is returned. While any source or destination IP can be chosen, IP flow verify helps administrators quickly diagnose connectivity issues from or to the internet and from or to the on-premises environment.

IP flow verify looks at the rules for all Network Security Groups (NSGs) applied to the network interface, such as a subnet or virtual machine NIC. Traffic flow is then verified based on the configured settings to or from that network interface. IP flow verify is useful in confirming if a rule in a Network Security Group is blocking ingress or egress traffic to or from a virtual machine.



Note: In Azure Active Directory (Azure AD), you can create complex attribute-based rules to enable dynamic memberships for groups. Dynamic group membership reduces the administrative overhead of adding and removing users.

When any attributes of a user or device change, the system evaluates all dynamic group rules in a directory to see if the change would trigger any group adds or removes. If a user or device satisfies a rule on a group, they are added as a member of that group. If they no longer satisfy the rule, they are removed.

Note: The ManagedBy property stores the Id of the VM to which Managed Disk is attached to. If the ManagedBy property is \$null then it means that the Managed Disk is not attached to a VM

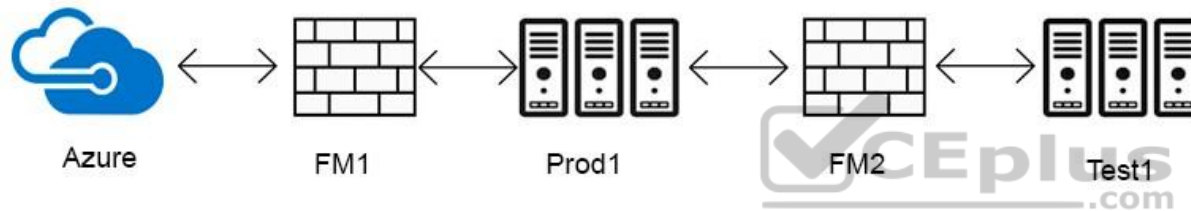

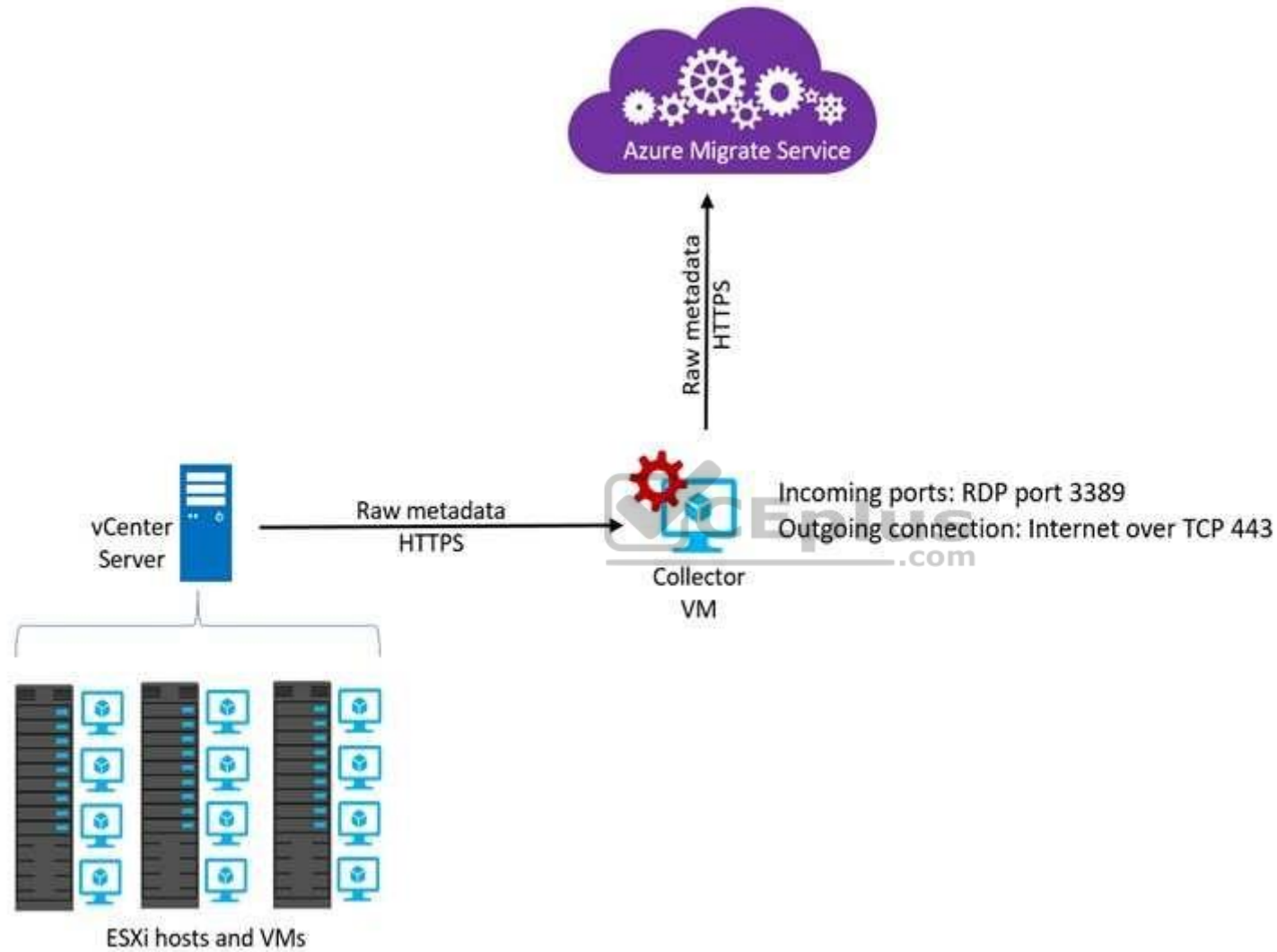


